The school opened with 41 students on the first day and currently has 630 students in the school. Since 2016 the school has experienced rapid growth and development, and moved to this permanent building in August 2018. Bremore ETSS currently provide Junior Cycle, Transition Year, Leaving Certificate and LCVP, and there are two classes for students with autism. The school has a diverse student and staff population; they value and embrace the range of backgrounds, experiences, energy and enthusiasm that the students and staff bring to the school.

Progress of the Meeting

The meeting will commence with the adoption of the Agenda for the meeting. This year motions were received to amend the Standing Orders that govern how we will run our Meetings. These motions will be dealt with at the start of the meeting when the Standing Orders are proposed and, if accepted as part of the Standing Orders by the delegates, will take effect once the Standing Orders are accepted (where possible). These are labelled "Standing Order Motions". The Standing Orders Committee will explain the process of debate and voting and there will be an opportunity to ask questions on anything you are unclear about.

Motions and Voting

At the AGM, a motion can be put to members once it has followed a simple two-step procedure. It must be presented by or on behalf of the proposing member and must also be seconded by another member. If it is not seconded, it is regarded as not having sufficient support to merit the attention of the AGM.

The proposer has a short (maximum 4 minutes) opportunity to present the motion. Members who wish to speak for or against the motion have up to 3 minutes each. If you wish to speak on a motion, please indicate clearly so that no time is wasted. Points of order or information may be taken from the floor during the course of the debate. When the debate is finished the proposer is afforded the opportunity to reply to the points raised (maximum 2 minutes). The vote is then taken by show of voting cards, or electronic equivalent, and is decided by majority.

Different Types of Votes

If a motion will affect how Educate Together acts as patron to its schools, the Chairperson will declare this a motion that can only be voted on by those schools operating with Educate Together's patronage. If a motion relates only to national school members or only to second-level members, this will also be declared by the Chairperson of the meeting. However, if the motion relates to Educate Together's other activities, all members will be entitled to vote and all voting cards will be counted. This is the reason for the different colour voting cards when the AGM is held in-person.

We hope that this provides a useful guide to the AGM. If you have any further questions, please ask the members of the Standing Orders Committee.

Standing Orders Committee Members

The Standing Orders Committee members are volunteers appointed by the board of directors. The standing orders committee currently consists of five members: two serving directors and three non-board members.

The two director members are Aidan Clifford, chair of the governance sub-committee of the board as well as the standing orders committee, and Richard Woulfe, Company Secretary to the Board of Directors.

Padraig Mannion is a long-standing supporter of Educate Together. He has been Chairperson of Bray School Project N.S. and a Board member of Wicklow ETNS. He has served on the Standing Orders Committee since 2006.

Pat Crowe is principal of North Kildare ETNS in Celbridge, Co. Kildare where he has taught since 1996. He is a former member of the Central Executive Committee of the INTO and has served on the Educate Together Standing Orders Committee since 2009.

Brian Smith was appointed chairperson of Adamstown Castle ETNS in December 2015. He served as a local and national trustee and director of Scouting Ireland for several years and joined the Educate Together Standing Orders Committee in 2018.

Lesley Byrne

Lesley Byrne is Principal of Clogher Road Community College which is a DEIS school in Crumlin under the patronage of CDETB and in partnership with Educate Together. Lesley also works with Maynooth University on the Turn to Teach programme, which aims to promote diversity in the teaching profession through a series of social-justice orientated widening participation initiatives. Prior to her current role, she was Deputy Principal in Belvedere College with special responsibility and a particular passion for the Social Diversity Programme. She started her teaching career in Newall Green High School in Manchester, which was a full service school serving one of the most deprived wards in the UK. It was here that her passion for social justice within education really grew. Lesley is currently a PHD candidate with Maynooth University and her particular area of research is how marginalised communities are represented in current and historic educational policy and is looking at how we can move from a deficit model of disadvantage to one that holds the values of different communities in equal standing. She worked closely with Project Sums, set up by Senator Lynn Ruane in providing free grinds to students who would not be able to access them otherwise. She is currently on the NAPD Senior Cycle Reform committee and is also on the steering committee for the Nurture Ireland project with Educate Together. A strong advocate for Senior Cycle Reform, Lesley strongly believes that the Irish education system needs a research based approach to becoming more equitable and a true praxis of Democracy.

Miriam Hurley

Miriam Hurley has been Principal of Dalkey School Project (DSP) for 13 years. She is a committed member of Educate Together network since joining the teaching staff of Monkstown ETNS in 1999. Miriam has contributed to Educate Together AGMs and General Forum group meetings regularly over the past 20 years. Miriam brings a broad range of educational knowledge and community building skills. An activist on equality issues, she is particularly interested in supporting Educate Together schools to be inclusive educational settings where all children's needs are met and the Educate Together ethos is nurtured and fostered. Miriam was a founding and committee member of the first LGBT teachers' group in Ireland through the INTO from 2004-2011. She has delivered workshops at ethos and equality conferences. Promoting restorative practices and student voice is central to her vision for building strong communities who change the world in positive and inclusive ways. During her time as Principal at DSP, the school community has become a leader in the Forest School network and DSP is one of 20 schools nationally in the DCU Changemaker network. The DSP community set up Kids Behind the Cuts group 2019 – 2020, garnering the support of hundreds of schools nationally, thus influencing policy on resources for children with additional needs. Miriam believes Educate Together has a vital role to play in shaping educational vision in Ireland and is committed to the strengthening and growth of Educate Together.

Theresa Burke

Theresa Burke became a Director of Educate Together in November 2020, after joining the Board's Finance Sub-committee in March of that year. Head of Governance and Finance with the Children Rights Alliance since 2018, Theresa qualified with the Association of Chartered Certified Accountants (ACCA) in 2005, becoming a fellow in 2010. She has worked as audit manager in accountancy practice, gaining extensive experience across many areas in the public and private sector dealing with small, medium and large organisations. Theresa also brings significant experience in the charity sector to the role, with up-to-date knowledge of the Charities Governance Code, and charity financial reporting requirements including Financial Reporting Standard 102 Statement of Recommended Practice (SORP).

9. Admission of new members

Blackrock ETSS

Blackrock Educate Together Secondary School opened on 31 August 2021 in temporary accommodation in the Sandymount Building, Simmonscourt Road. Patronage of the school was awarded to Educate Together following a patronage determination process that was held at the end of 2020. Donal Evoy, principal and

Simon Rogers, deputy principal, welcomed 37 pupils on opening day. The school's permanent location will be located in Blackrock and a planning application has been lodged. When fully developed the school will cater for up to 1,000 students.

Gorey ETSS

Gorey Educate Together Secondary School opened on Wednesday I September 2021 following a patronage determination process held at the end of 2020. The school opened in temporary accommodation on the Fort Road in Gorey. Principal Conor Berry and deputy principal John Murphy and their team welcomed 35 students on opening day and when fully developed the school will cater for 500 students. The Department of Education are currently seeking a permanent home for the school.

10. Adoption of the Strategic Plan

Stronger Together – Educate Together's Strategic Plan 2022 – 2026 was finalised by the board of directors in January 2022. This plan was developed by the CEO and national office team in collaboration with the board over two years. The development process included engagement with member schools, consultation with external stakeholders and partners, review of the demographic, educational and policy context and reflection on our values, constitution and charter.

The board is now asking members to formally adopt this plan, which will guide the organisation's work over the next five years.

II. Adoption of Senior Cycle Ethical Education Curriculum

The Senior Cycle Ethical Education Curriculum was finalised in 2021 after a three-year development process which involved consultation, piloting and external evaluation by the School of Education in UCD. A report on the curriculum and the development process is available to members <u>here.</u> The board is now asking members to formally adopt this curriculum, which will be taught at senior cycle in Educate Together schools.

12. Policy Motions

Policy motions for this year can be voted on by all members.

2022/01 This AGM calls on the Board of Directors to establish a working group including representatives from different Educate Together members for the purpose of researching and providing guidance to schools regarding good practice related to including and actively supporting LGBTQ+ children and families and addressing relevant issues of equality in keeping with the Educate Together ethos.

Boards of Management Kilcolgan ETNS, Knocknacarra ETNS and Galway ETSS

2022/02 This AGM requires that Boards of Management of Educate Together secondary schools can include a priority category for children coming from Educate Together 'feeder' primary schools in their Admissions policy.

Board of Management of Stepaside ETSS

Rationale

Boards of Management are already able to have a Priority I for siblings. The interpretation of the Education (Admission to Schools) Act 2018 allows for this. The equality of access argument, whereby priority is not given to any child (other than siblings) in Educate Together Admissions policies is recognised as important. However, it does not take account of the competition for school places that is a feature of moving from primary to secondary school. Many secondary schools have feeder schools named in their Admissions policy. Thus where ET secondary schools do not have ET primary schools named as feeder

schools the children from ET primary schools are at a disadvantage when seeking secondary school admission. Also, an important cohort of parents make a conscious choice to align with the Educate Together ethos for their child(ren). As such they purposefully and deliberately opt for the Educate Together philosophy and approach. They begin by seeking admission to Educate Together primary schools. This often entails additional travel and logistical burdens that the parents are prepared to incur and support in pursuit of their choice. Those leaving ET primary schools and seeking admission to an ET secondary school are an important part of the Educate Together community and it is reasonable that they can expect that the Educate Together secondary school admission policies will support their choice of an Educate Together education ethos at second level and take account of the competing considerations to the equality of access principle.

2022/03 This AGM calls on the Board of Directors to open discussions with the Education and Training Boards to extend their co-patronage relationship at second level to primary schools with a view to working together in the future to open and manage primary schools in Ireland.

Board of Management Carlow ETNS

Rationale

There are now 23 CNS schools and they are expanding more quickly than our own schools. While we celebrated opening 7 primary schools in 2019, they had opened 10. It appears that almost all divested schools are being taken on by the ETB. Rather than waiting for the inevitable when they become bigger than our own network, we have an opportunity now to get involved so that if we were to join forces, we could ensure that certain conditions, precious to ET, can become central to any future relationship.
